

"The Digital Health Equity Network (formerly Digital Health Equity Reference Group) is a dynamic collective dedicated to promoting equitable access and utilisation of digital health tools. With a diverse membership group, members convene monthly to exchange insights, share progress and explore avenues to address disparities in healthcare delivery through digital solutions. Importantly, each meeting facilitates knowledge exchange and collective learning through guest speakers or through the DHEN members," LJ says.

The DHEN's objectives for 2024 are to – "Raise understanding of digital health equity (mapping, definitions, policies, strategies), what does the data tell us?, and identify community champions to connect throughout the network (speakers for the network)". Actions that related to the objective are: Ō Mātou Reo, a National Consumer event being hosted in Tāmaki Makaurau, which is about understanding digital health quality, and developing a white paper following the hui and gaining feedback."

Data Standards

Following on from an active 2023, the Data Standards (DS) group has set itself an objective to promote the capture of the data behind telehealth services being delivered in the primary and community settings to demonstrate and raise awareness of what is actually happening in these parts of the health sector. The starting point for this piece of work is going to be the development of a problem statement paper to identify the burning issues, highlight good and not so good examples (a learning approach), current coding situation and where improvements may be required. Meetings of this group are monthly (generally the 3rd Wednesday at 11.30am) and anyone with an interest in data standards and this piece of work in particular are encouraged and welcome to get involved.

Research, Audit and Evaluation (RAE)

Congratulations to the RAE group for successfully developing the recently released Telehealth Stocktake, which was the topic of the telehealth webinar held on the 28th of February 2024. A recording of this webinar is available on the website here and is well worth watching if you couldn't attend the live event or, if you did attend, to refresh on the rich discussions and knowledge sharing that occurred during the webinar. Artificial Intelligence (AI) Community of Practice – Watch this space!

Boosting access to care: Rural communities see positive impact - Ka Ora Telecare update

The new rural telehealth service by Ka Ora Telecare is making positive steps in improving healthcare accessibility in remote areas, garnering resounding praise from both patients and clinicians alike.

The service, which rolled out in November last year and includes access to virtual GP or nurse practitioner appointments, received 3,973 calls nationwide during the height of summer between 22 December 2023 and 7 January 2024, and a resolution rate of 83 percent. To date, 3,286 patients have contacted Ka Ora from 363 practices.

The service has swiftly gained momentum, with 87 of 200 plus eligible rural practices onboarded, underscoring the urgent need and widespread recognition of the potential of telehealth.


